Terms & Conditions

Flogas Dairy Hot Water Referral Scheme

Please note this scheme will be operational until April 1st, 2023. Any referrals made after this date will not be eligible for a referral gift under this scheme.

- 1. The candidate agrees to be bound by these terms and conditions and confirms that all information is true, current, and complete.
- 2. The Flogas Dairy refer a friend scheme is open to those aged 18 years or over and does not include employees (and their families), any affiliates, subsidiary companies, or anyone else who may be involved or connected with Flogas or DCC Group.
- 3. All referrals must be made through the Flogas website.
- 4. Flogas reserves the right to verify the eligibility of all referrals and may, in its sole discretion, refuse to pay the referral fee if the customer fails to satisfy eligibility requirements.
- 5. Flogas reserves the right to amend or withdraw the 'refer a friend' promotion at any time or to alter the amount paid.
- 6. This scheme applies only to persons who are active Flogas LPG Dairy customers ("referee") and where the referee refers a new candidate who is eligible to become a Flogas LPG Dairy customer in the Republic of Ireland and Northern Ireland.
- 7. Under the scheme the referred person can be your friend, relative or acquaintance.
- 8. The referee must have an active account and have received a bulk delivery within one year of the date of the referral.
- 9. Existing dairy farmers of Flogas can refer up to 5 farms under this scheme.
- 10. The referral gift detailed in this scheme is 150 litres of Free LPG credit applied to a Flogas Dairy LPG account.
- 11. The referee and the candidate they refer are eligible for a referral / sign up gift of 150 litres of Flogas Free LPG Credit if the referred person successfully signs up to a Flogas Dairy LPG account and receives their first bulk delivery within three months of completing the referral form. Once the first bulk delivery is received within this timeframe, a credit of 150 litres of Free Gas will be applied to both LPG accounts.
- 12. The Free Gas Credit is not redeemable in cash and will only be applied to a Flogas LPG account.
- 13. The referee will not be eligible to receive the referral gift under this scheme in the event that the referred person is already on the Flogas database at the date of referral or if Flogas have already received their details but have not yet entered them on to their database.
- 14. Only the candidate being referred to the system must fill out the form, the referral form cannot be filled out by the referee on behalf of the candidate being referred without their permission. This is the responsibility of the referee and is subject to the Data Protection Act 1988 and 2003. The referee will indemnify Flogas for any loss or claim arising out of the referee's failure to procure such consent.
- 15. By filling out the Flogas referral form, the candidate confirms their consent to their details being stored and to be contacted by a member of Flogas staff.

- 16. Referrals will be accepted up until midnight March 31st 2023. Any referrals made after this date will not be eligible for a referral gift under this scheme.
- 17. Candidates can only be referred to Flogas once. In the event that a candidate is referred to Flogas by more than one referee, only the first person to refer that candidate to Flogas (with the referred person's permission) will be eligible for a referral gift under this scheme.
